About the Workshop:

Savannah Junkins, PA-C, has been working with patients with substance use disorder (SUD) for 5 years and will share her knowledge about substance use disorder assessment, diagnosis, treatment, harm reduction, and patient/family education. She will also explain how to integrate medical and behavioral health care into the workflow to provide a comprehensive approach to the patient's needs.

This session will provide 1.5 hours of Controlled Substance Prescribing Continuing Education and 1.5 hours of DEA-MATE content required for DEA-registered health care practitioners.

Objectives:

- Explain the assessment and diagnosis process of individuals who screen positive for substance use disorder (SUD)
- Discuss the prescribing practices for medication-assisted treatment (MAT) of SUD
- Describe the components of developing an effective SUD treatment plan, incorporating the use of an interdisciplinary team, and how to implement this into the workflow of the primary care practice
- Discuss safety and overdose prevention education for the patient and family including recognizing signs of abuse or misuse

This program will benefit physicians, physician assistants, nurse practitioners, registered nurses, dentists, pharmacists, veterinarians, and all other healthcare professionals interested in this topic.
